This includes providing the very highest caliber coaches, ice time, training support, and performance enhancements. US Speedskating provides competitive opportunities at world and Olympic championships, world cups, and other international events. These athletes represent the United States and are in pursuit of Olympic medals.

Governance - US Speedskating is composed of a 10 person board of directors that is responsible for planning, direction and policy for the organization. There are typically two in person meetings per year and additional conference calls to conduct US Speedskating business. The board consists of retired athletes, independent members and representatives from membership throughout the United States. US Speedskating governs both short track and long track speedskating.
